government that says if you are truly needy we will find a way for you to help yourself so that you do not become a ward of the state instead of a government that distributes handouts and favors to its constituents in exchange for their votes.

public officials who act on the principles and values of our Founding Fathers versus politicians who use polls and focus-groups to tell them what to do.

a government that relies on the rule of law versus one that relies on amnesty to deal with messy legal problems.

a society in which all men and women are truly equal rather than one in which a never-ending stream of claims are made for protected status.

a system as responsive as the local fire department versus one that hides behind 800 numbers and a maze of automated instructions.

an election process in which the voter has a real option to Tweedle-dum and Tweedle-Dee versus one in which the citizen must hold his nose before voting.

that competency and effectiveness matter more than balance and diversity.

creating wealth is more important than redistributing wealth.

a government that listens and does what the people are unable to do for themselves rather than one that listens and does what it pleases.

public officials who act as stewards of the people's money rather than bureaucrats who spend recklessly because it's not their money.

government that remains small in order to make it work effectively versus one that has become so large it doesn't work at all, just gets bigger.
